# Directions for Use

Muscle aids in quick recovery from stress, including disease, sunlight/shade issues, vertical mowing, top dressing, aerification, drought, and poor drainage.

## **Recommended Rates**

For best results apply as a foliar spray in sufficient water for thorough coverage (typically 1 to 2 gallons per 1,000 sq. ft.) When applying higher rates of products, and for maximum plant uptake and safety of all foliar fertility applications, it is best to water product to the soil surface before the warmest part of the day.



### **Greens & Tees:**

7.5 to 15 oz. per 1,000 sq. ft. (2.5 - 5 gallons/Acre) every 14 to 28 days.



# Fairways & Other Turf:

3.75 to 15 oz. per 1,000 sq. ft. (1.25 - 5 gallons/Acre) every 14 to 28 days.



## **Trees & Ornamentals:**

1 to 2 gallons per 100 gallons of water.

Apply fertilizer in accordance with best management practices established by your local Cooperative Extension or State University. Observe any State or local fertilizer regulations pertaining to content and timing of application.



#### **Storage & Container Disposal**

Store above 32 degrees Fahrenheit. Store in dry place in original container only. Keep lid tightly closed. Keep away from flames and intense heat. Dispose of containers in accordance with local regulations.
