## Directions for Use

### Recommended Rates

For best results apply as a foliar spray in sufficient water for thorough coverage (typically 1 to 2 gallons per 1000 sq. ft.). When applying higher rates of products, and for maximum plant uptake and safety of all foliar fertility applications, it is best to water product to the soil surface before the warmest part of the day. This product may stain. Keep off unwanted areas: patios, driveways, fences, buildings, painted areas. As a precaution spray off unwanted areas with water after applying.



#### Greens & Tees:

2 to 10 oz. per 1000 sq. ft. (0.02-0.10 lbs. N per 1000 sq. ft.) every 7 to 14 days.



#### Fairways & Other Turf:

2 to 20 oz. per 1000 sq. ft. (0.02-0.20 lbs. N per 1000 sq. ft.) every 7 to 28 days.



#### Trees & Ornamentals:

16 to 64 oz. per 100 gal. of water as necessary.

**Apply fertilizer in accordance with best management practices established by your local Cooperative Extension or State University. Observe any State or local fertilizer regulations pertaining to content or timing of application.**

#### Storage & Container Disposal

Store above 32 degrees Fahrenheit. Store in dry place in original container only. Keep lid tightly closed. Keep away from flames and intense heat. Dispose of containers in accordance with local regulations.
